### 1.0.GENERAL:-

The Memorandum of Understanding is entered into on this 10<sup>th</sup> day of Oct 2023 at 11:25 am

BETWEEN

**Dr. Gargee Chakraborty, Principal, M.N.C Balika Mahavidyalaya** (hereafter referred as College), situated at Nalbari: 781335 Assam, India affiliated to Gauhati University, Guwahati.

AND

**Dr. Shantanu Kr. Dutta, Member Secretary**, (herein referred to as PCBA), a statutory organization of Government of Assam under the Department of Environment and Forests, situated at Bamunimaidam, Guwahati-781021, Assam.

Whereas both parties are committed to promoting sustainable practices and reducing environmental impact, they hereby agree to work together to achieve the following objectives:

1. To promote sustainable practices in the College and its surrounding communities, with a particular focus on reducing pollution and improving waste management practices. To work collaboratively on research, development and implementation of sustainable practices in the College, including renewable energy, waste reduction and water conservation.
2. To develop joint programs, initiatives, and activities to raise awareness and educate the community about environmental issues and the importance of sustainability.
3. To establish a monitoring and reporting system to evaluate progress towards shared goals and identify opportunities for continuous improvement.
4. The College agrees to implement specific environmental policies and programs including reducing energy consumption, noise pollution, reducing carbon emission promoting sustainable transportation and implementing a waste management plan.
5. To jointly apply for research projects on topics of mutual interest to various funding agencies.
6. To jointly organize outreach programmes related to various contemporary environmental issues. The PCBA agrees to provide technical expertise and support, including training and



education, internship program to the College to develop and implement sustainable practices. In this regard, students and teachers of the College who are engaged by PCBA shall be given participation certificate from the PCBA.

7. Both parties agree to establish a joint committee to oversee the implementation of this MoU and to meet regularly to review progress and identify opportunities for collaboration.

8. Both parties agree to contribute resources and funds as needed on mutual understanding to support the activities outlined in this MoU.

This MoU shall be effective for a period of five years from the date of signing, unless otherwise amended or terminated by mutual agreement in writing by both parties with a three month notice. This MoU does not create any financial obligation on the part of either party. Both parties agree to comply with all relevant laws and regulations, and to conduct their activities in a manner that is consistent with their commitment to environmental sustainability.


