

PREAMBLE

This memorandum of understanding is made between Damdama College, Hajo, Assam-781104 and Mahendra Narayan Choudhury Balika Mahavidyalaya, Vidyapur, Nalbari, Assam-781335

Damdama College was established on the 9th of August, 1978 in the temple town of Assam- Hajo. Set in the bustling locality of Kulhati, the college has evolved to be an institution of repute. The college has six full-fledged departments. The college sits on a campus of 44 bighas of land and is easily accessible by road. The nearest railway station is the Kamakhya railway junction at a distance of about 31 km. A brief history of this college must also include contributions of the Damdama Higher Secondary School. This very famous school allowed its classrooms to be used by the students of the College. Classes were held from 7 am to 11 am. Only on the 2nd January 1982, classes began within the college itself. And the degree classes under the University of Gauhati started in 1984. The National Assessment and Accreditation Council (NAAC) inspected the College on the 26-27th of April 2006 and placed it in the B grade. The strength of this institution lies in academic achievement and its healthy environment. A rural college catering to the academic needs of local youths coming from agro-based working-class families requires a very soft, careful managerial acumen in its build-up process. A dedicated and learned faculty as well as the non-teaching personnel ensures that students develop their latent potential in a homely yet intellectually stimulating environment. It is our humble effort to provide a holistic education for the empowerment of students as citizens of the global world.

Mahendra Narayan Choudhury Balika Mahavidyalaya is a premier institution of higher education for girls in Nalbari, one of the traditionally enlightened districts of Assam. It was established on 01-08-1979 solely with the liberal charity of a great philanthropist, Late Mahendra Narayan Choudhury. The college has taken all possible steps for promoting higher education especially among the girls' so as to mould them into responsible citizens of the country and better human beings. The college is affiliated to Gauhati University, Guwahati and duly recognized under 2 (f) and 12 (B) by University Grants Commission in 1996. In 2004 NAAC has accredited the college with B++ grade. In 2006 UGC has recognized the college as a College with Potential for Excellence (CPE). Again, in 2016 NAAC has accredited the college with 'A' grade. Presently, the college has a strength of approximately 2200 number of students enrolled in various programmes.

1. INTENT OF WORK

Through this document based on the principle of equality and mutual benefit, Damdama College and Mahendra Narayan Choudhury Balika Mahavidyalaya hereby agree to undertake activities focussing on enrichment of knowledge and co-operate in establishing closer links involving:

- Exchange of Faculty members.
- Exchange of Undergraduate students.
- Joint Research activities.
- Organization of joint Seminars, Conferences and Workshops.
- Exchange of Educational materials, Publications and Academic informations.
- Joint survey work.

It is intended that specific collaborative arrangements between the two institution will be set out in separate agreements.

It is also proposed that Damdama College and Mahendra Narayan Choudhury Balika Mahavidyalaya will work together to identify and secure new opportunities in support of the proposed collaborative activities.

2. FINANCIAL INVOLVEMENT:

Financial involvement in connection with any programme undertaken as per the MOU will be sorted out and arranged by the institutions after mutual discussion.

3. ARBITRATION:

3.1 Except in noting the provisions of this MOU, no use of the name, symbol, sign of one institution shall be made by the other.


3.2 This agreement shall become effective from the date of its signing and continue thereafter for five years subject to revision or modification by mutual agreement.

3.3 Termination by one institution, with prior intimation to the other institution before at least three months, will automatically invalidate the MOU.

3.4 In case of any controversy regarding scope and any provision of this MOU, mutually agreed decision of the Principal, Damdama College and the Principal, Mahendra Narayan Choudhury Balika Mahavidyalaya will be final.
